YOUR RIGHTS (ART. 7)

- 1) You have the right to obtain the confirmation of the existence or not of your personal data, even if not yet filed, and their communication in an intelligible way.
- 2) You have the right to obtain the indication:
 - a) of the origin of your personal data
 - b) the aim and the way in which your data are treated
 - c) of the logic used in case of the treatment effected by electronic instruments
 - d) of the name of the responsible of your data, indicated by art. 5, comma 2
 - e) of the persons or categories to who your personal data can be communicated
- 3) You have the right to obtain:
 - a) the updating, the changing or even the integration of your data
 - b) the cancellation, the transformation in an anonymous way or the stop of your data, treated not in a legal way, included the ones for which the conservation is not necessary
 - c) the confirmation that the operations indicated in the points a) and b) have been brought to the knowledge of the ones that have your data, excepted the case where this is not possible.
- 4) You have the right to oppose:
 - a) for legitimate reasons to the treatment of your personal data
 - b) to the treatment of your personal data concerning the dispatching of advertising material or direct sale, or for market researches or commercial communications.
